FIRE FIGHTER EXPECTATIONS

_____ Being a volunteer firefighter demands dedication and training. We hold training sessions every Tuesday evening from 7:00 p.m. to 9:00 p.m. We recognize that your family and job take precedence, but we expect the fire department to be a high priority as well. Members are required to participate in at least 60% of our training events. For the first several months of your membership, we would like for you to be at even more than 60% if possible. Life can be unpredictable, and we understand that absences happen; however, consistent training is vital for effectively handling the diverse situations we encounter. It takes time and commitment to be an integral part of our team.

_____ Emergencies occur 24 hours a day, 7 days a week, 365 days a year. McGregor Volunteer Fire Department is expected to respond no matter the time or day. As a volunteer fire fighter, you are not expected to be at every call, but there is an expectation that you are able to respond to emergencies if you are available. While there is not a "quota" or rule on exactly how many you must respond to, ensure that you are willing to respond when you are able to, even if at times it may be inconvenient.

_____ McGregor Volunteer Fire Department depends on fundraising for a large portion of our yearly funds to operate. Being a member of a volunteer department, you are expected to participate in fundraising events. We understand that you may not be able to make each and every fundraiser, but participating as much as possible is crucial to our success.

_____ There will be times that the fire department needs members to participate in assorted duties to help the fire department function/operate. Not all members are able to always help, but you must be willing to participate if you are available. Some examples include yearly Christmas toy drives, as well as other public relations events.

AUXILIARY EXPECTATIONS

_____ Emergencies occur 24 hours a day, 7 days a week, 365 days a year. McGregor Volunteer Fire Department Auxiliary is a crucial part of our department, and participation is very important when the need arises. Some duties of the auxiliary on emergency scenes will be to assist fire fighters / first responders with their physical well-being. Examples include making sure fire fighters are staying hydrated, not overheating, and making sure food is available when needed. You also may be expected to take CPR training.
